

### **a. Protected Methionine:**

- ❖ 55% DL - Methionine in rumen protected form.
- ❖ Rumen protection- >54%

### **b. Live yeast culture**

- Colony Forming Unit (CFU) Count- 12 Billion CFU per gram.  
If the CFU content per gram is lower then adjustments in the quantities used have to be made to conform to finished product specifications.

### **c. Vitamin A & D<sub>3</sub>**

- Vitamin A= 10 Lakh IU/gram
- Vitamin D<sub>3</sub> = 2 Lakh IU/gram
