This Company invites sealed quotations from Licensed Contractors (under Contract Labour ( Regulation & Abolition ) Act, 1970 registered with Labour Department, Government of Andhra Pradesh for supply of Manpower for carrying out certain jobs exclusively identified by the Principle Employer in the Main Dairy Plant at Visakhapatnam and its units at Tuni, Rajahmundry ,Narsipatnam, Srikakulam, FMP Amudalavalasa, Vizianagaram, Ramabadrapuram, Ice Cream Plant, Feed & Fodder Plant, All Bulk Cooling Centres and at Rangampeta Dairy Plant in East Godavari District and also at packing plant , Hyderabad etc.,. The approximate manpower requirement per day is expected to be in between 700 to 850 man-days. The operations in the plant will be carried out all round the clock. The vendor should quote commission per man day only. Comprehensive statutory liabilities (Employer share) such as minimum wages, Employees Provident Fund, Employees State Insurance Corporation, statutory Bonus in addition to the contractor's commission will be paid to the contractor by the Principle Employer on raising the bill every month on the due certification by the Head, Personnel Department. The Leave with wages, Statutory Bonus, National Holidays and Festival Holidays components will be paid to the contractor at the end of the contract period / calendar year basing on the eligibility of the workmen deployed by him. The period of contract is for 12 months and may be extended for further period considering the satisfactory performance of the contracting agency.

The tenderer should comply with the following statutory requirements.

1. License under Contract Labour (Regulation & Abolition) Act, 1970
2. Registration under EPF & MP Act with EPFO
3. Registration under ESI Act with ESIC
4. Income Tax Permanent Account Number (PAN)
5. GST Registration Number under GST Act
6. Professional Tax Registration Number in GVMC Area.
7. Any other enforceable Law, when made by appropriate Governments

The successful bidder should furnish the Bank Guarantee of Rs.5.00 Lakhs and Security Deposit for Rs.8.00 Lakhs. The successful bidder is required to indemnify the Principal Employer against all risks those are apprehended or anticipated during the employment period of Contract Labour during the work order period.

The Licensed Contractor should raise his comprehensive bill duly endorsed covering all components and performance of job by each contract labour within 05 days of the following month. Each contract labourer ought to maintain his/her individual Bank Account and wages are credited to Bank Accounts only. All payments to Licensed Contractors through bank transactions only.

Interested Agencies may quote their bid duly enclosing all necessary documents along with Demand Draft for Rs.25,000/- (Rupees twenty-five thousand only) refundable on any nationalized / scheduled bank drawn in favour of Sri Vijaya Visakha Milk Producers Company Limited payable at Visakhapatnam.
